Built on a plot of 15.000 m2, the finca has a constructed area of 460 m2 divided on two floors. The ground floor contains a bedroom suite, large living room with fireplace and open ceiling to the first floor, dining room, super farmhouse style kitchen, Newly installed recording studio, and a guest cloak room. On the first floor there are 4 bedroom suites, one of which is the master suite with own terrace and dressing room. The house has a splendid south facing covered terrace with dining and sitting areas, and around the house is a charming garden with automatic irrigation and a large swimming/spa pool heated with newly installed solar panels. Moreover there is 40m by 20m all weather horse arena for showjumping. The finca is built with excellent finishes and qualities and has central heating.

The finca is located just 15 min. from Palma centre and some 5 minutes from the small town Bunyola with its charming city centre and weekly market.
