Release Commitment:

Subject to there being no copyright or other legally binding restrictions Licensee shall release singles in the territory within 120 days following delivery to and acceptance by Licensee of such single. In the event that Licensee has not done so the Licensor shall have the right to serve notice upon Licensee requiring release of the said single. If Licensee fails to comply within one hundred and twenty (120) days from the date of service of such notice, the Licensor shall be entitled to terminate this agreement by written notice and all rights in the unreleased masters shall revert to the Licensor in their entirety without further formality.

Reserves:15% to be liquidated in next accounting period.


